# MINUTES OF PUBLIC HEARING ON APPLICATION FOR OPERATING PERMIT

The Board of Directors of the Prairielands Groundwater Conservation District ("District") met in a public hearing within the boundaries of the District at 208 Kimberly Dr, Cleburne, TX 76031, on July 15, 2024.

President Charles Beseda presided and called the public hearing to order at 9:00 a.m., announcing the meeting open to the public.

Burleson Pecan Grove, LLC for a proposed Operating Permit (OP-24-062) for authorization to drill a new well (PGCD-003451) to be located in Johnson County at 1620 Sequoia Way, Burleson, TX; not to exceed 1,776,250 gallons annually for 2024→2028; Filling a Pond or other Surface Impoundment (KB); and
- Infinity Dance Holdings, LLC for a proposed Operating Permit (OP-24-063) for authorization to drill a new well (PGCD-003474) to be located in Johnson County at 5965 CR 913A, Godley, TX; not to exceed 108,500 gallons annually for 2024→2028; Commercial Use (KB).
