MINUTES OF PUBLIC HEARING ON APPLICATION FOR OPERATING PERMIT

- 2) Mountain Peak SUD, for authorization through an Operating Permit (OP-24-064) to amend an existing well registration to substantially alter and increase the maximum design production capacity from 650 GPM to 800 GPM. The existing well (PGCD-

000478) is located in Ellis County at 2200 Whitetail Dr, Midlothian; Public Water Supply (KB).
